**Section 1:** The Regulations of Connecticut State Agencies are amended by adding Sections 29-367-1 to 29-367-3, inclusive, as follows:

(NEW) **Sec. 29-367-1 The Connecticut Model Rocketry Code: Introduction.**

Regulations of the Department of Public Safety, Sections 29-367-1 to 29-367-3, inclusive, shall be known as the Connecticut Model Rocketry Code.

(NEW) **Sec. 29-367-2. Authority Having Jurisdiction.**

For the purposes of regulations adopted by reference under Section 29-367 of the Connecticut General Statutes, "the authority having jurisdiction" means the Commissioner of Public Safety. The Commissioner of Public Safety is the authority having jurisdiction regarding the proper administration, application, interpretation, and modification of the requirements contained within Sections 29-367-1 to 29-367-3, inclusive.

(NEW) **Sec. 29-367-3. Adopted Standard.**

(a) The following standard promulgated by the National Fire Protection Association (NFPA) is hereby adopted as part of Section 29-367-1 to 29-367-3, inclusive:

NFPA 1122 -1997, Code for Model Rocketry;

NFPA 1125-1995, Code for the Manufacture of Model

**Section 2:** Sections 29-106q-1 through 29-106q-10, inclusive, of the Regulations of Connecticut State Agencies are repealed.

**Statement of Purpose:** To update regulations for safe design, construction, manufacture, testing, certification, storage, sale, shipping, operation and launching of rockets propelled by rocket motors, including, but not limited to, solid, liquid and cold propellant, hybrid steam or pressurized liquid rocket motors. This code is intended to prevent injury to life, damage to property and protection from the hazards incident to the design, construction, manufacture, testing, certification, storage, sale, shipping, operation and launching of such rockets, as required by Section 29-367 of the Connecticut General Statutes.
